PARKING POLICY CONSENT FORM

I understand and am fully aware of the following parking policies of the Residences on Hollywood Beach Condominium Association:

1. A maximum of two (2) valet parking permits are allowed per unit. A valid parking permit must be visibly displayed on the driver side "windshield" of each registered vehicle.
2. Valet parking is complimentary only for registered vehicles displaying a valid parking permit.
3. Prior to issuance of a parking permit, vehicle registration, driver's license, and resident information will be verified and recorded in an electronic database which will be used to enforce the parking policies.
4. Any violation of the parking policies or lack of proper permitting will result in towing/booting of vehicle/s and may lead to forfeiture of parking privileges, fines, and eviction.
5. All guests must valet park at a rate of four (4) dollars daily or five (5) dollars overnight. A Valet parking pass may be purchased from Valet for guest parking or additional vehicle parking at a rate of one hundred (\$100) dollars monthly or thirty (\$30) dollars weekly.
6. No commercial vehicle, boat, camper, van or recreational vehicle may be parked by a resident on the condominium property. All commercial vehicles and contractors must sign in and obtain a contractor's pass from Valet before parking in designated areas within the condominium property.
7. A resident may purchase up to Two (2) remote controls per unit for the purpose of Self Parking at a price of One Hundred (\$100) dollars each. Remote controls are the property of the purchaser. The Association is not responsible for loss. Upon expiration of a lease or sale of a unit, parking privileges will be cancelled and any remote controls previously purchased will be deactivated.
8. No repair or washing of vehicles is allowed within the parking areas.
9. Valet is not required to park or operate any vehicle which is, or appears to be in Valet's reasonable judgment, oversized, unsafe, or which is in violation of any state, local or municipal ordinance and/or regulation as to the operation or condition of the vehicle.
10. Motorcycles represent a significant liability risk and thus require a special parking permit which is available at a cost of two hundred forty dollars (\$240.00) per year payable to Park One Inc.

I agree to comply with these stated policies and any other Association policy, rule, and/or regulation which may apply to the parking and operating of vehicles within the condominium property.
